



Vision 2035: Creating Our Future Together

To be truly future-ready, internal auditors need to understand and proactively anticipate change and its impact on the profession. What will the future of the internal audit profession look like in 2035? How will the role of the internal audit profession evolve, and what strategies are needed to enhance its value? The Foundation's Vision 2035 project aims to address critical needs through understanding the future of the internal audit profession, considering the evolving business landscape, technological advancements, and global challenges.



This project will help us prepare for the future by engaging a global group of experts, including volunteer leaders, representatives from the International Internal Audit Standards Board, The IIA's Professional Certifications Board, the Internal Audit Foundation's Board of Trustees and Committee of Research and Education Advisors, and representatives from regional bodies and IIA Institutes.



During the three research phases of the project – foundational research, qualitative research, and a quantitative survey – we will actively seek input and gather perspectives from internal auditors and their stakeholders around the globe.

We are pleased to report significant progress in shaping our collective future. The foundational research phase of the Vision 2035 project has been successfully completed. Additionally, we have seen the successful execution of the 1.5-day Future Foresight session and the collection of

valuable insights in Amsterdam through roundtable discussions with Affiliate leaders and chief audit executives (CAEs) during the Global Assembly and International Conference.

The qualitative research and analysis phase of the project has also reached its conclusion. By actively engaging more than 500 internal audit professionals and stakeholders through roundtable focus groups or one-on-one interviews, inclusive of efforts during the Global Assembly and International Conference, we have gathered valuable insights.

In Phase 3 of the Vision 2035 Project, the Foundation deployed an online survey based on the feedback and insights our team has gathered. This survey was translated into multiple languages to ensure a global reach. While predicting the future is uncertain, the project recognizes the importance of taking action as we shape the future we want. The full report will be available July 2024.

Record-Breaking Scholarship Applications

RECORD-BREAKING SCHOLARSHIP APPLICATIONS

2023 marked a historic achievement for the Foundation, with the highest number of IAEP grant applications and Michael J. Barrett Doctoral Dissertation applications ever received. Additionally, the Foundation team relaunched a scholarship funded by the Sawyer Family Endowment: the Larry B. Sawyer Student Scholarship – open to both undergraduate and graduate students interested in a career in internal audit.

Investing in the Next Generation

Shaping and growing the profession is a critical focus for the Foundation. We do this by supporting colleges, universities, and students worldwide with programs, grants, and scholarships to help them succeed.

ACADEMIC PROGRAMS

In 2023, we welcomed 12 new Awareness schools and two new IAEP schools to our programs, continuing the positive trend from 2022 of 16 new schools added to our programs. This expansion reflects a growing commitment to fostering internal audit education globally.

We are excited to celebrate the advancement of two programs to the Center of Excellence level of the IAEP Program: Texas A&M University (Brazos Valley, TX) in 2022, and Nelson Mandela University (South Africa) in 2023.



"One change we have noticed after becoming recognized as a Center of Excellence is the new employer connections that we have been able to make. In this last year, we heard from 4-5 new companies who are hiring in internal audit positions and want to promote their opportunities to our students. We now have a system in place to share these opportunities with our program's alumni, giving them another network to draw upon if they need help with career opportunities down the road. Our alumni also benefit from being able to list a Center of Excellence certificate earned, which elevates their resume when applying for experienced internal audit roles. Students often don't realize what the recognition means when they are in school, but clearly see its benefits in the workforce."

Dissertation Title: Professional Identity of Internal Auditors in South Africa

Dissertation Title: The Effect of Audit Committee Internal Audit Expertise on Financial Reporting and Operating Performance

Jennifer Puccia is a fifth-year Ph.D. candidate in accounting at Michigan State University. She expects to graduate in May of 2024. She received a Bachelor of Business Administration in Accounting and a Master of Science in Management Information Systems from Texas A&M University. Puccia is a licensed CPA in the state of Texas. Prior to joining the Ph.D. program in 2019, she worked as an Information Technology Auditor for EY in Dallas, Texas, and as an Internal Audit Senior Consultant in Technology for Protiviti in Chicago, Illinois. During her time in client services, Puccia focused on executing and managing internal audits, external audits, risk assessments, initial public offering readiness evaluations, and National Institute of Standards and Technology (NIST) cybersecurity reviews. 
