The Internal Auditing Education Partnership (IAEP) program was developed to respond to the growing interest in internal audit education at institutions of higher learning. The program also addresses a general need of practitioners interested in hiring students who possess a well-rounded skill set for conducting internal auditing. Being a member of the IAEP program requires a commitment from the school, the local IIA chapter, and the global IIA Academic Relations Department. The application for the program requires that a school meet the qualifications outlined in the Internal Auditing Education Partnership Program Requirements & Operating Framework and complete a five-year business plan that discusses all aspects of the school's internal audit program as well as the faculty's commitment. Applications are accepted twice a year on April 1 & October 1.
