# Call for Speakers for IIA Canada 2022 National Conference

These sessions will address how and what our leaders in internal audit and risk are doing to meet the demands/needs of their clients, stakeholders and team members.

#### **Fraud and Ethics**

Post-COVID is presenting organizations with an opportunity to assess, and even reset, their approach to ethics. Ethics touches so much of our decision making post pandemic; for example the decision to require all employees be vaccinated in many workplaces. Meanwhile, the potential for fraud has increased as new legislation and organization mandates come into effect which are viewed as a requirement to do business in this changed world. These sessions will examine how we go forward as internal auditors, as advisors and assurers in the areas of ethics and fraud.

#### Soundbite Sessions (hot topics)

What is new, what is hot, what is trending? These sessions will speak to concepts and ideas outside the box.

## **IIA Quality Assessments**



The <u>Quality Assessment Manual</u> for the Internal Audit Activity published by the Internal Audit Foundation in 2017, responds to issuance of The IIA's International Standards for the Professional Practice of Internal Auditing (Standards), the related changes in the internal audit profession, and the increasingly demanding business environments in which the profession operates.

In accordance with The IIA's Standards, "The chief audit executive must develop and maintain a quality assurance and improvement program that covers all aspects of the internal audit activity" (Standard 1300). The Manual was designed to provide guidance and step by step modules for the chief audit executive (CAE) in establishing and maintaining a quality assurance and improvement program, as well as for assessors, internal and external, in testing and assessing that program. The current edition updates and expands that guidance and enhances the models and assessment tools.

The latest edition has five chapters based on the principal elements of the quality program required by the Standards, with a continued strong emphasis on external assessments.
