#### Internal Audit Vision 2035



Over the next decade, the internal audit profession is expected to evolve significantly as rapid technological progress, disruptive forces, and emerging risks reshape the landscape.

This evolution will involve shifts in organizational operations, a broadened and more diverse talent pipeline, and enhanced ability and credibility for auditors to assess and address new and emerging risks in the eyes of stakeholders.

#### North America Risk in Focus 2026

#### **Top Emerging Risks**

- Cybersecurity remains the #1 risk (86% of respondents), with Al-driven attacks increasing in scale and sophistication.
- **Digital disruption (incl. Al)** surged 17 percentage points in two years; now a Top 5 risk for 53% of respondents.
- Geopolitical and macroeconomic uncertainty spiked sharply (up 19 points year-over-year), driven by new U.S. policy shifts and global volatility.
- Business resilience and regulatory change continue to rank among the top organizational risks.





#### **Hot Topics**

- Geopolitical Uncertainty: Internal auditors are expanding advisory roles, helping organizations adapt to tariffs, supply chain challenges, and funding cuts.
- **Digital Disruption & Al:** 
  - Generative AI is transforming risk profiles and workforce structures.
  - Many organizations are forming **Al governance teams** that include CAEs.
  - Internal audit is increasingly leveraging Al for efficiency, automation, and data **insights**, while also auditing AI ethics, bias, and control frameworks.
