# Panel Facilitator: John Falck

#### Panelists – Sarah Khan





This required extensive integration capabilities for complex IT environments in a heavy regulated industry with HIPAA, NIST, SOX, PCI, HITRUST and URAC compliance and external SaaS/SOC needs. At the time UnitedHealth Group's Optum division acquired Catamaran in 2015 for \$21.5B, the program was responsible for protecting 45M+ patient records and 1B+ annual business processing transactions.

Steve has an additional 13 years of combined **cyber security experience spanning the healthcare**, **logistics, manufacturing, judicial system, and the insurance industries**. In addition, Steve previously held information security and IT audit management positions at CVS Health (formerly CaremarkRx), as well as senior positions at Sears and Arthur Andersen.

# Overview



- Founded in 2012, and patterned after the Chief Information Officer (CIO) of the Year Award sponsored by the Association of Information Technology Professionals (AITP Chicago), SIM-Chicago and the Executive Club of Chicago, the Chicago CISO of the Year program recognizes outstanding CISOs for their contributions to their organizations, the Information Security profession and the local community.
- The award is overseen by the Chicago CISO of the Year Program, a not-for-profit affiliated with AITP Chicago, and managed by local area security leader volunteers.
- The CISO of the Year Award lets the Chicago CISO community
  - celebrate the achievements of leading Chicago security executives
  - elevate the visibility of the CISO role within the Chicago business community
  - strengthen the community of Chicago CISOs
- The program is volunteer, non-profit, peer driven (by CISOs for CISOs)
- Supported by partnering professional associations (including ISACA)
- Supported by selected sponsoring security vendors

# How it works



- Each year, we solicit peer and colleague nominations for Chicago CISO of the Year
  - From co-workers, colleagues, partners and vendors anyone with direct experience working with the nominee
  - Goods and/or services may NOT be exchanged for a nomination
  - Two CISO categories, ENTERPRISE (>\$4bn revenue) and MID-CAP (< \$4bn)
- Nominees submit applications for the award and, if accepted, are interviewed by a panel of peer judges (CISOs, CROs, CIOs)
- Judges and peer CISOs meet the nominees through a series of mixer events
- A formal scoring method is employed to select two finalists in each category, who are interviewed by CEO judges and the winner selected
- Winners are announced in October
