

After the full day of workshops, we would like to invite you to the 2-hour happy hour to network and connect.




# IIA Represented at the RMA IA Conference

**Certification Renewal** - Log in to the Certification Candidate Management System (CCMS) to begin your renewal. The renewal deadline is 31 December each year. If you fail to renew your Active certification by the deadline, it will enter a Grace status, and as a result, you are no longer approved to represent yourself as a certified individual. Individuals remaining in Grace for 2 years will enter a Revoked status and must reapply and retest if they wish to become certified again. 

#### **Measuring Internal Audit's Performance**




## **Automating Internal Audit Testing Processes**




