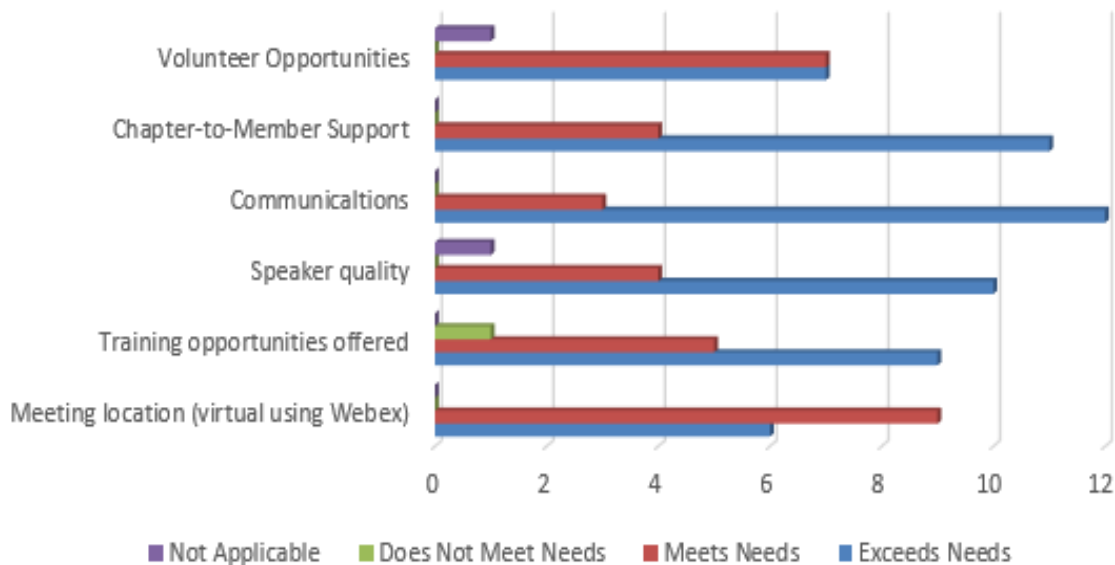

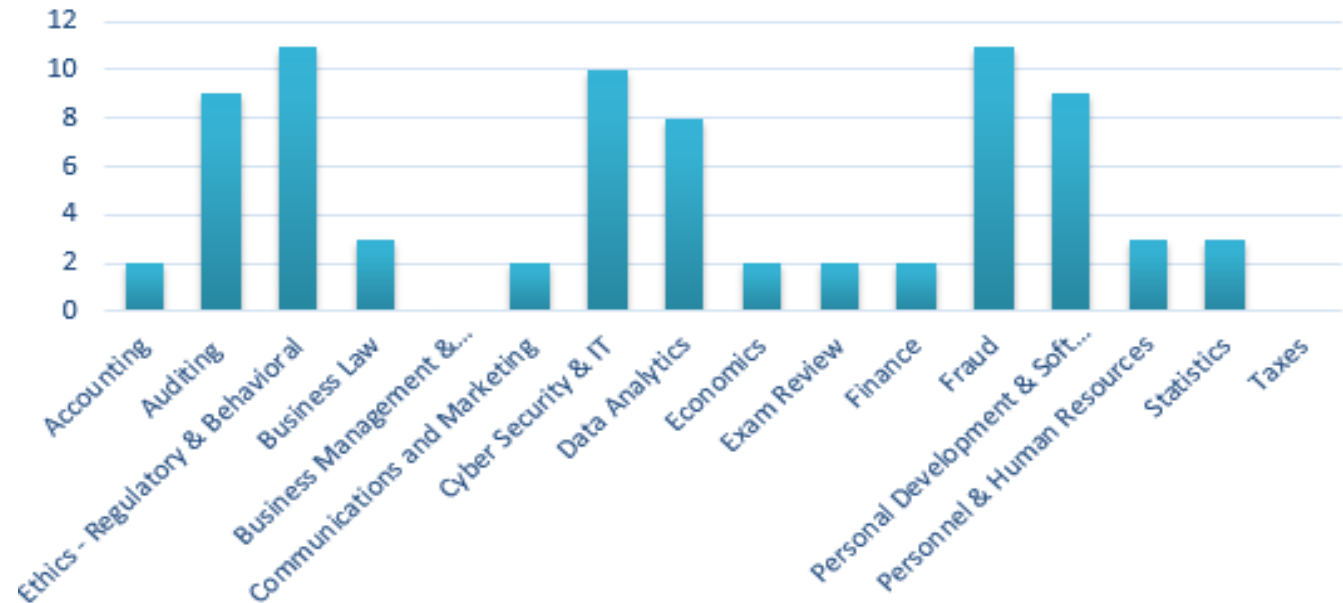
Overall, are you satisfied with the performance of the Tulsa Chapter IIA for the current Chapter year?	Count	Percent

No	1	2.2%

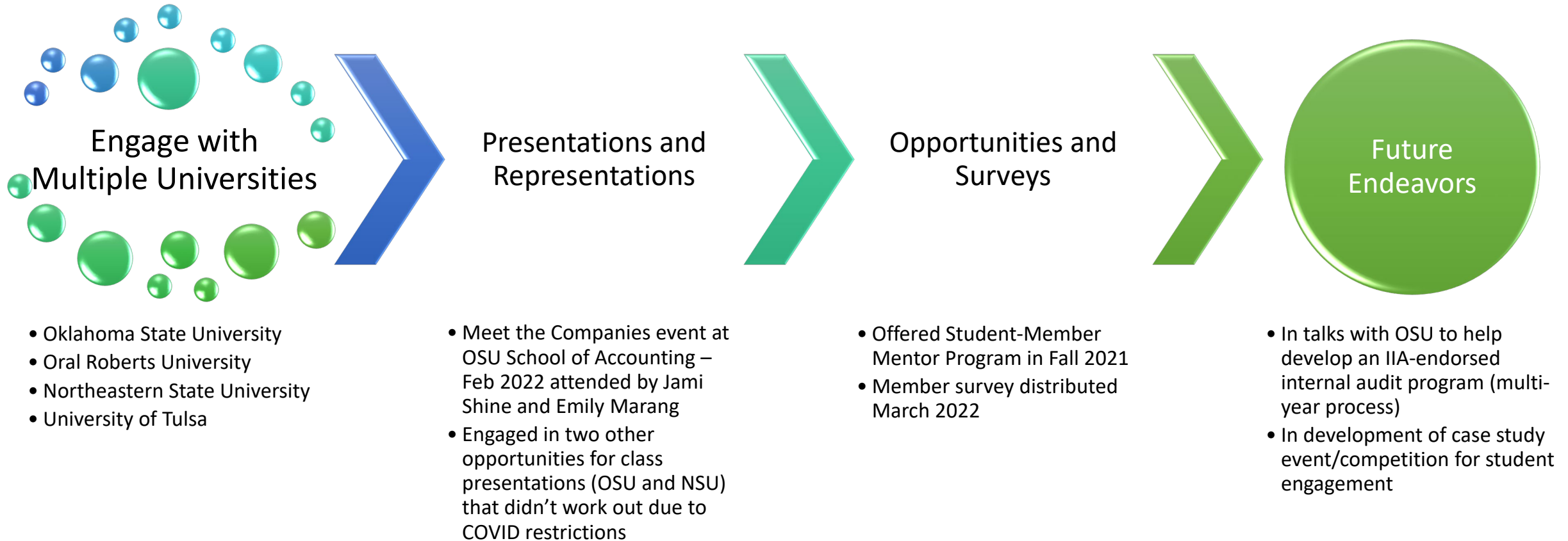
