### GLOBAL INTERNAL AUDIT STANDARDS

IIA released the new Global Internal Audit Standards on January 9, 2024, and will take effect January 9, 2025. Please note that changes to the CIA syllabi and exam are forthcoming. Please refer to <https://www.theiia.org/en/standards/2024-standards/global-internal-audit-standards/> for updates.

### NEW CERTIFICATION RENEWAL POLICY, CPE POLICY, AND NEW CERTIFICATION PRICING

#### Certification Renewal Policy

Effective September 1, 2023, the IIA requires that certifications that are in a “Grace” or “Expired” status are renewed by the end of the calendar year (12/31/2023). If not, you may lose your designation!

Individuals with CIA or CRMA certifications in “Grace” status must complete and report their CPE hours. To return to “Active” status, CPE hours must be up to date as of the previous reporting period.

CIA and CRMA certified individuals in an “Expired” status on 1/1/2024 will have their designation revoked and will be required to recertify. To return to “Active” status, all CPE hours must be up to date and reported, as of one reporting period, complete the reinstatement application, and pay the reinstatement application fee.

CCSA, CFSA, CGAP and QIAL holders will not be able to recertify since these are no longer supported.

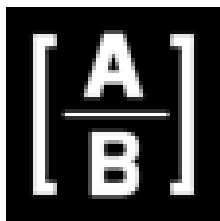
