This is it folks!

Time to submit your comments on the proposed Global Internal Audit Standards COUNTDOWN TO THE CLOSE OF THE PUBLIC COMMENT PERIOD

30 May deadline for the English survey is fast approaching.



As I'm writing this, the countdown clock says 26 days, 12 hours, 6 minutes, and 56 seconds remaining to submit your comments on the proposed standards. There are important proposed changes and you have the right to contribute to the standard setting process and how the profession will be governed in the future.

As one option, I'm using the following simple framework to gather my comments as I read through the standards and prepare to respond to the survey. I jot down the principle under the relevant section or domain and note any implementation challenges or areas I feel are particularly supportive of the profession.

If you are pressed for time, divide and conquer with your team. For Chief Auditors, focus on Domains III and IV. If you're a supervisor, lead or staff level, take a look at Domain V and the section Considerations for Implementation and Evidence of Conformance.

Remember, if you indicate you follow the standards in your internal audit work, you'll want to see what is new and be prepared to update your practices and prepare your governing body to comply.
