

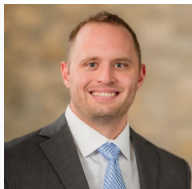

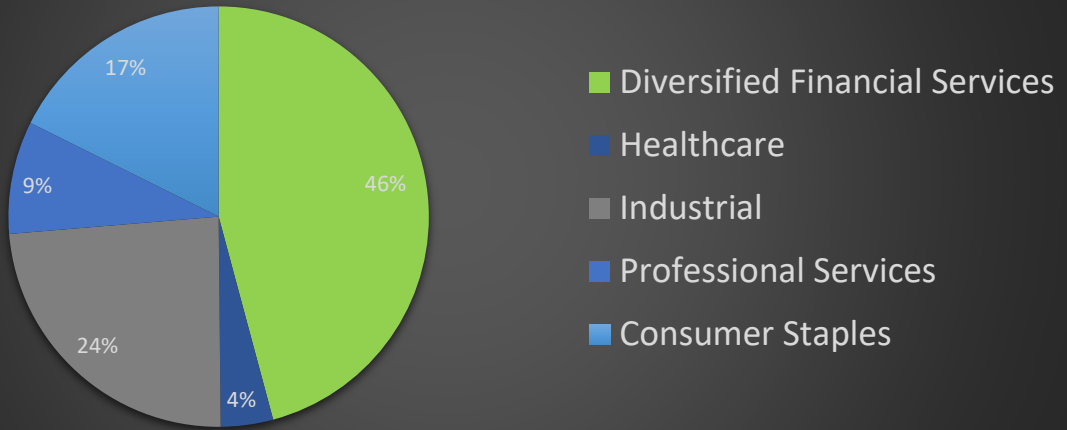

If you have any requests or suggestions for future topics and/or speakers not indicated in your survey response, we'd love to hear from you!

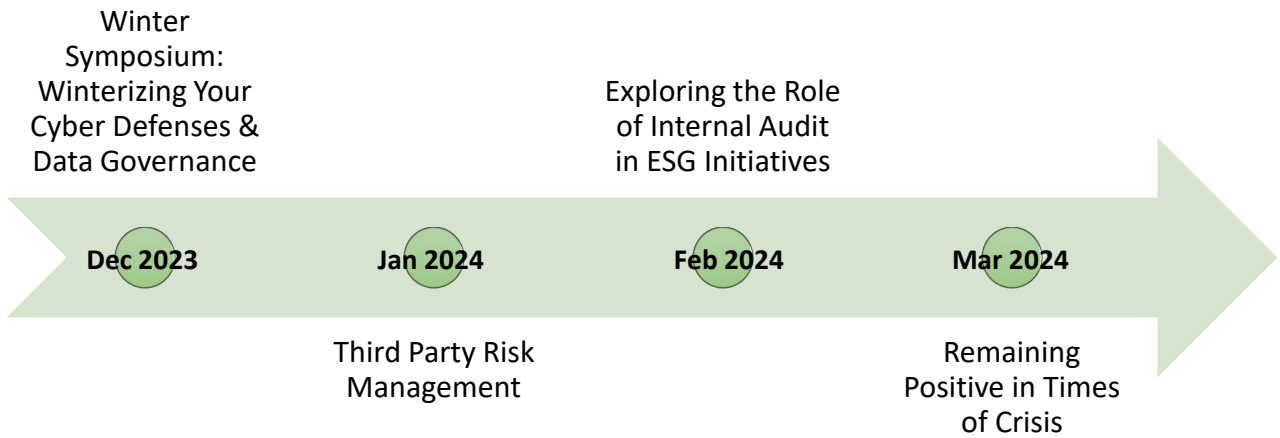
